**AGENDA & ANNUAL ORGANIZATION MEETING RESOLUTIONS**  
**January 5, 2026**

WHEREAS, Section 174, sub-paragraph 2, of the Town Law calls for the Board of Fire Commissioners of the Seaford Fire District to hold an annual organization meeting during the first fifteen days of January, and

WHEREAS, the Secretary of the Fire District has previously caused a notice of this meeting to be given in accordance with the requirements of the Public Officers Law, and a copy of the legal notice and affidavit of publication of same will be duly attached to the minutes of this meeting at the time that a copy of this resolution is attached to the said minutes, and

WHEREAS, certain business of the Fire District must be transacted at this meeting in order to organize operations for the 2026 calendar year;

In accordance with recent statutory amendments, volunteer firefighters below the rank of assistant chief will not be approved to attend a training program or seminar outside of New York State unless in-state training opportunities are properly evaluated (the Chief to complete the report to the Office of Fire Prevention and Control [OFPC]), and all district funded travel will be based upon the most cost effective and reasonable method as determined by the Board;
